The Town reserves the right to approve/deny the application within **10 days** of its receipt. If the Town denies the application, the non-refundable deposit will be refunded. The park rental fees are due **two weeks prior** to the event. Upon written request, if the event is canceled one week prior to the event date, the Town will refund the park rental fee(s) only. Refunds are NOT given due to inclement weather, please provide a rain date. (initial)
