# ABSENTEE VOTING FOR REGISTERED VOTERS DELMAR, MARYLAND/DELAWARE

### Who may vote by absentee ballot:

- 1. Members of the Armed Forces, their spouses and dependents.
- 2. Members of the Merchant Marine, their spouses and dependents.
- 3. Civilian employees of the U.S. Government serving outside the United States, their spouses and dependents.
- 4. Personnel of American Red Cross, Women's Auxiliary Service, Pilots, USO, and Society of Friends who are serving with the Armed Forces outside the United States, their spouses and dependents.
- 5. The ill and disabled.
- 6. Those confined in or restricted to an institution.
- 7. A registered voter who, for any reason, is absent from the United States on Election Day.

#### How to vote by absentee ballot:

- 1. Complete the enclosed application and return to the Board of Supervisors of Elections, 100 S Pennsylvania Avenue, Delmar, DE/MD 21875.
- 2. Deadline for receipt of completed application by the Elections Office is the Tuesday before the election.
- 3. Execute the ballot and return it to the Board of Supervisors of Elections. Emergency ballots must be received NO LATER THAN THE CLOSING OF THE POLLS ON ELECTION DAY.
- 4. A separate application must be make for absentee voting for each election.
- 5. If you receive an absentee ballot, you must vote by that method even if your plans change and you find that you could vote personally at the polling place.

**WARNING!** The absentee voting law provides that anyone who willfully signs any false application or oath, or who willingly does any act contrary to the terms and provisions of the Absentee Voting Law with intent to cast illegal vote or to aid another in doing so, or who willfully violates any of the provisions of that law and who applies for a ballot under any other name than his own, shall, upon conviction be subject to a fine of \$1,000.00 or to imprisonment for not more than two years, or to both, in the discretion of the court.
