## **RIGHT OF WAYS AND EASEMENTS**

**This building permit authorizes the builder/contractor to construct the structure only within the footprint of the submitted plans. This permit DOES NOT give authorization to construct or install utilities in the Town of Delmar right-of-ways or easements. If any construction or installation of utilities is to be done in the Town of Delmar right-of-ways or easements, you MUST FIRST obtain written authorization from the Department of Public Works.**

### **REQUIRED INSPECTIONS**

1. **Footing and foundation inspection.** Footing and foundation inspections shall be made after excavations for footings are complete and any required reinforcing steel is in place.
2. **Concrete slab and under-floor inspection.** Concrete slab and under-floor inspections shall be made after in-slab or under-floor reinforcing steel and building service equipment, conduit, piping accessories and other ancillary equipment items are in place, but before any concrete is placed or floor sheathing installed, including the subfloor.
3. **Frame inspection.** Framing inspections shall be made after the roof deck or sheathing, all framing, fire blocking and bracing are in place and pipes, and vents to be concealed are complete and the rough electrical, plumbing are approved.
4. **Energy efficiency inspections.** Inspections shall be made to determine compliance with Chapter 13 and shall include, but not be limited to, inspections for: envelope insulation R- and U-values, fenestration U-value, duct system R-value, and HVAC and water-heating equipment efficiency.
5. **Final inspection.** The final inspection shall be made after all work required by the building permit is completed.

## **COMMERCIAL BUILDING PERMIT APPLICATION REQUIREMENTS**

1. For new construction and additions. Should be specific to DE Agencies & MD Agencies
  - Three sets of signed and sealed plans, including MEP's
  - All plans must be fully detailed to meet the standards of the International Building Code. (see Code Enforcement Officer for which edition of the IBC)
  - An approved site plan is required at time of submittal
  - Two copies of COMcheck thermal envelope
  - One copy of the COMcheck for the mechanical and electrical systems
  - State of Maryland/Delaware Construction License is required prior to issuance of the building permit
2. One set of plans is required to be submitted to the Wicomico County Fire Marshall's Office, located at 125 N. Division Street, Room 201 of the Government Office Building. For additional information for fire safety reviews, contact the Fire Marshall's office at 410-548-4994. OR – Sussex County Fire Service, Delaware Fire Service Center, 22705 Park Ave., Georgetown, DE 19947, Ph: 302-856-5298, Fax: 302-856-5800.
3. For purposes of fee determination, construct shall be as follows:
  - A. For new construction and additions, the greater of:
    - i. The proposed cost stated on the building permit application or;
    - ii. The cost as determined from the most recent Building Valuation Data published by the International Code Council

## **COMMERCIAL ALTERATIONS AND RENOVATIONS**

- Two sets of signed and sealed plans, including MEP's
  - A site plan may be required based on the scope of work
1. For alteration or renovation of existing buildings, the proposed cost stated on the Building Permit Application.
  2. Plan review fee must be paid at the time of submission; payment shall be made to the Town of Delmar. The building permit fee shall be paid at the time or prior to the issuance of the building permit.
